**Request for trading halt**

**The Star Entertainment Group Limited (ASX code: SGR) – Listing Rule 17.1**

The Star Entertainment Group Limited (ASX code: SGR) (**The Star**) requests that a trading halt be applied to its ordinary shares in accordance with ASX Listing Rule 17.1, effective immediately.

- (a) The reasons for the request are as follows:
- i. The Star notes that the final report following the 2024 Independent Inquiry into The Star undertaken by Adam Bell SC (in accordance with the Casino Control Act 1992 (NSW) (the **Report**)) has today been provided to The Star and released by the NSW Independent Casino Commission (**NICC**). The Star is considering the Report and implications it may have for disclosures concerning its financial results for the year ended 30 June 2024 (**FY24 Results**);
  - ii. The Star is finalising other disclosures in relation to its FY24 Results; and
  - iii. The Star intends to respond to other matters raised in media articles referring to, among other things, The Star's FY24 Results and its financial and liquidity position.
- (b) The Star requests that the trading halt continues until the earlier of:
- i. such time as The Star releases an announcement in relation to the matters referred to above; or
  - ii. the commencement of trading on Monday, 2 September 2024.
- (c) The Star is not aware of any reason why the trading halt should not be granted or of any other information necessary to inform the market about the trading halt.
